



Privacy Notice for Langton Lane Swimming Club:

This notice explains what personal data (information) we hold about you, how we collect, how we use and may share information about you. We are required to give you this information under data protection law.

Simon Langton Grammar School for Boys collects, uses and is responsible for certain personal information about you. When we do so, we are regulated under the Data Protection Act 2018 and General Data Protection Regulation (GDPR) which applies across the European Union (including in the United Kingdom) and we are responsible as ‘controller’ of that personal information for the purposes of those laws.

(How we use your information)

The categories of information that we may collect, process, hold and share include:

- Membership information such as (name, membership number, date of joining, DOB, address, membership status, class schedule, next of kin, emergency contact details, phone number, email address);
- CCTV footage.
- Financial details such as (payment amount, when payment was last collected, card details).

Why we collect and use this information

We use your data to:

- Enable you, or your child to make use of the Langton Lane Swimming Club facilities;
- To check that all payments have been processed and collect any outstanding monies due;
- Enable swimming teachers to schedule lessons;
- Enable management to allocate resources to the club;
- Protect pupil and guest welfare;
- Protect the school buildings and site;
- Enable the club to run events and provide information on club closures, or reduced timetables, or events being ran.

The lawful basis on which we process this information

- The data subject has given consent to the processing of his or her personal data for one or more specific purposes;
- The parent/guardian of the data subject has provided consent for their child’s data to be processed for one or more specific purposes;

- Processing is necessary for compliance with a legal obligation to which the Langton Lane Swimming Club is subject;
- Performance of a contract with you and legitimate interests (for running the Langton Lane Swimming Club business, to recover debts due to us, to keep our records updated and to provide the contracted service).

Storing this information

We hold your Information until you no longer wish to be a member of the Langton Lane Swimming Club. However, we may also keep your information if this is necessary in order to comply with our legal obligations.

Who we share this information with

We do not share information about you with any third party without explicit consent unless the law and our policies allow us to do so.

Where it is legally required or necessary (and it complies with data protection law), we may share personal information about you with:

- Security organisations - to ensure the safety and welfare of pupils, staff, visitors and guests
- Emergency Services - to ensure the safety and welfare of our guests and to meet any legal obligations and to ensure the safety of the whole school community
- Management, when making decisions regarding the Langton Lane Swimming Club.
- Our finance team when collecting payments.
- Swimming teachers.

Requesting access to your personal data

Under data protection legislation, members have the right to request access to information about them that we hold. To make a request for your personal information, contact the Data Protection Officer - sdodds@thelangton.kent.sch.uk

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed;
- claim compensation for damages caused by a breach of the Data Protection regulations
